AMTA-NM Government Relations Report 10/5/2016

The Government Relations Committee has been focused on correcting the NM Massage Board's confusing and punitive interpretations of the Continuing Education and Instructor Rules, with a focus on protecting the rights of licensees and eliminating meaningless hurdles to out-of-state instructors teaching continuing education classes in NM. The basic issue is that the Board is refusing to allow credit for NCBTMB-approved courses taken in NM if the instructor has not jumped through the proper hoops to become Registered or Visiting Instructors, despite the fact that it would approve the same courses taught by the same instructors if taken out of state. Your AMTA-NM Board believes this interpretation is not consistent with a plain reading of Rule 16.7.11.9

- A. The board will accept the following types of continuing education which contribute directly to the licensee's massage therapy practice:
- courses of study offered by registered massage therapy schools; massage therapy instructors; massage, bodywork, or allied healthcare professional organizations, NCBTMB continuing education providers, and accredited colleges and universities.

Instead, the Board is expecting the STUDENT to ensure that the Instructor has dotted all 'i's and crossed all 't's in getting the course approved. We believe that the Board's interpretation unfairly punishes students for the lapses of instructors. Moreover, the Massage Board is insisting that all CE courses in NM be taught by Registered or Visiting Instructors, even if the teacher is exempt from massage licensure or the class is taught in a Registered Massage School, again violating a plain-language interpretation of the rule.


Your Government Relations Chair has been attempting to get the Massage Board's Rules Committee to clarify the rule for more than a year, but the committee had not met since the last Rules Hearing in November 2014. At the last MT Board meeting on September 6, two schools and the administrator sent letters to the Board asking for better communication and changes in the Board's punitive interpretation of the Rules. The Board took no action, and severely limited comment from members of the profession and public who packed the hearing room. In response, the business owner elicited the help of Sen. Peter Wirth (D-Santa Fe), who arranged a meeting with Regulation and Licensing Superintendent Mike Unthank and top members of his staff on September 28. Your GR Chair and representatives from one of the schools were also asked to attend.

The meeting seems to be a success. The Superintendent shared our concerns when explained, and the Massage Board has scheduled a special meeting to address the concerns on October 9 in Albuquerque. We are hopeful the Board will . . . (cont'd pg. 4)

(cont'd from pg. 3) . . . accept our preferred interpretations, but the business owner plans legal action if our needs are not met. Changes in the licensing act are also possible.

The next regularly scheduled Massage Board meeting is January 11, 2017 either in Santa Fe or Albuquerque. Your Government Relations Committee believes that it is important that more members of the public attend Massage Board meetings to persuade the Board to adopt more practical rules, so we will update you about the place and time of future meetings.

Easy Face Cradle Cover DIY

We have all done it, spent the money on disposable face cradle covers for our massage chairs. Then perhaps we have settled for tearing a paper towel or even switching to the Select-a Size rolls and splitting two sheets. This is a simple DIY for making a disposable face cradle cover out of a roll of Viva paper towels.

I used Viva, however, you can use any soft paper towel of your liking.

I personally like this technique because it allows me to prep them ahead of time and I like that the flaps fall nicely in the cradle.

(Full disclosure I have to thank a colleague, Andrew Nez, for sharing this technique.) I hope you enjoy it and it helps you and your business.



Step 1: Roll of Viva or other soft/cloth-like paper towel



Step 2: Lay out about 5 -7 sheets



Step 3 : Cut a Y shape from about midway up the towel (drawn for demonstration)
